Registration Basics

RCW 50B.04.020(3)

The department of social and health services shall:

(c) Register long-term services and supports providers that meet minimum qualifications;
(d) Discontinue the registration of long-term services and supports providers that: (i) Fail to meet the minimum qualifications applicable in law to the approved service that they provide; or (ii) violate the operational standards of the program;

RCW 50B.04.020(3)

The department of social and health services shall:

(e) Disburse payments of benefits to registered long-term services and supports providers, utilizing and leveraging existing payment systems for the provision of approved services to eligible beneficiaries under RCW 50B.04.070;

What is a registration?

- Registration is a type of license under chapter 35.04 RCW
- Registration grants approval by a specific entity to do a form of work

What is a contract?

- A contract is an agreement between DSHS and a provider.
- Under Chapter 39.42 RCW, DSHS must contract with providers to pay for WA Cares services.
- Contracting establishes the means for providers to obtain approval from beneficiaries prior to providing services.
- Contracting establishes the monitoring program necessary for ongoing implementation of the registration.

Registration with contract

- Under 50B.04.020, registration is a requirement to be a provider for WA Cares benefits
- The registration approves a provider to do approved services
- Within the registration requirement, a provider must have a contract.
- The contract provides the framework for DSHS to issue payments to providers on behalf of beneficiaries through a designated payment system



Registration Process

RCW 50B.04.020(3)

The department of social and health services shall:

(c) Register long-term services and supports providers that meet minimum qualifications;
(d) Discontinue the registration of long-term services and supports providers that: (i) Fail to meet the minimum qualifications applicable in law to the approved service that they provide; or (ii) violate the operational standards of the program;

Minimum Qualifications

- The provider must:
 - Have a valid license for the service(s) they want to provide beneficiaries
 - Pass a criminal background check
 - Have an active WA Cares contract for the service(s) they want to provide beneficiaries
 - Agree to the operational standards set by the program

Operational Standards

Operational standards will be adopted in rule

• Examples:

- Notify the department of address change
- Hold liability insurance
- Cooperate with monitoring activities
- Submit payment claim requests within 60-days of service
- Use ProviderOne to submit preauthorizations to beneficiaries and submit claims for payment of services
- Notify the department if a beneficiary passes away or has a major incident during service provision
- Notify the department of changes in ownership
- Notify the department if no longer meet the minimum qualifications
- Report suspected abuse, abandonment, neglect, or financial exploitation to Adult Protective Services and Law Enforcement when applicable

Becoming a registered provider

- Complete an application
 - Provide proof of meeting minimum qualifications for the service(s) they want to provide
 - Provide documentation necessary to obtain a DSHS contract for WA Cares Fund Program
- Complete a background check
 - A Character, Competency, and Suitability review may be needed for background checks with prior criminal convictions
- Obtain a DSHS contract for WA Cares Fund Program
- Once registered, a provider will be listed on the Community Living Connection website and beneficiaries can choose to work with the provider.
